RELATED TO THE QUESTIONNAIRE ABOUT THE NEW CORONAVIRUS (2019-nCoV)

TITLE OF DATA PROCESSING

Questionnaire about the new coronavirus (2019-nCoV) to prevent spreading of the infection.

SUMMARY OF DATA PROCESSING

Ministry for Innovation and Technology ordered Universities to perform a survey about the health conditions of the university citizens according to the epidemic situation because of the new type of coronavirus.

PURPOSE OF DATA PROCESSING

The purpose of data processing is to inform the government (the ministry and the operational staff) about the potential risks of the health conditions of the university citizens to avoid the wide spreading of the infection.

DATA PROTECTION IMPACT ASSESSMENT

Data protection impact assessment not needed.

LEGAL BASIS OF PROCESSION

Consent of the person concerned.

ADDITIONAL INFORMATION ABOUT THE LEGAL BASIS OF PROCESSION

Regulation (EU) 2016/679 of the European Parliament and of the Council Article 9. Paragraph 2 point (i): processing is necessary for reasons of public interest in the area of public health, such as protecting against serious cross-border threats to health or ensuring high standards of quality and safety of health care and of medicinal products or medical devices, on the basis of Union or Member State law which provides for suitable and specific measures to safeguard the rights and freedoms of the data subject, in particular professional secrecy

Act 1997:XLVII Article 4. Paragraph 1 point (d): The purpose of the health-related and health-identifying data [...] to take the necessary actions for the sake of public health and epidemic interest if needed [...].

All data will be erased after expiry of the emergency phase entered into force by the government regulation 40/2020. (III. 11.).

SUBJECTS OF DATA PROCESSING

The subjects of the data processing are all of the university citizens of the Károli Gáspár University of the Reformed Church in Hungary. University citizens are the students and all the staff who are in employment relationship with the university.

ESTIMATED NUMBER OF SUBJECTS

Approximately 9000 people. The number could be specified based on the questionnaires filled out.

TYPE OF PROCESSED DATA

Name; type of legal relationship (student or employee); address; the fact of traveling abroad, destination; fact of contact with somebody who is suspected or confirmed to be infected with a new coronavirus; health conditions (potential symptoms).

SOURCE OF DATA

The source of data are the persons concerned.

METHOD OF DATA PROCESSING

Computer-based.

GENERAL INFORMATION ABOUT DATA SECURITY

Data security measures are supported in the system of data processor. After the summarizing of the questionnaires, data will be sent to the ministry by the mailing system of the university Rector's Office.
